



# Spokane Valley City Council - January 9, 2024

Each year the Mayor appoints members to the various committees which serve the City, or where the City holds board positions, and / or where the City is, by its community standing, represented. One such committee is the Tourism Promotion Area Committee (TPA).

In 2022, City staff and hoteliers reached agreement on petitioning Council to create a TPA. City Resolution 22-017 formally accepted that petition followed by adoption of Ordinance 22-016, establishing a City-wide Tourism Promotion Area. The ordinance provides the implementation procedures and policies for the new TPA.

The first Spokane Valley City Council meeting for 2023 opened with Council's confirming Mayor Pam Haley's appointments of Sara Fesler, Amanda Alcamo, Grant Guinn, Bernadette Crain, and Lee Cameron to the City's then newly created Tourism Promotion Area Board. The appointment of the TPA Board completed the TPA establishment process.

Late last year, a TPA Commissioner resigned creating a vacancy for calendar year 2024. Mayor Haley appointed Jessica Glasson from Holiday Inn Express to fill the vacancy. The motion to approve that appointment passed unanimously.

Annually, the Mayor also makes appointment recommendations to place Councilmembers on the various regional and in-house boards and committees. The following are the Mayor's recommendations for each Councilmember's committee assignments.

- The motion to approve the Mayoral assignments passed unanimously.

At its January 2nd meeting, Council requested a review of the City Logo Policy and Governance Manual related social media guidelines. In a discussion of those guidelines and policies, Kelly Konkright, the City Attorney, explained in detail the rules for Councilmembers' use of the City logo and using or implying City sponsorship of the Councilmember's use of social media sites. This presentation was necessitated by the improper use of social media involving the City by a Council member.

Ordinance 24-001 is a city-initiated code text amendment revising City Code to provide flexibility in the number of required Planning Commission meetings. Currently, City Code requires the Commission to hold at least one regular meeting each month, in not less than nine months each year. Further, it would ensure that there are not two consecutive months without a meeting. The Planning Commission, after a public hearing, recommended Council adopt Ordinance 24-001.

In 2013, Council approved a franchise with Zayo Group, LLC for installation and maintenance of fiber optics telecommunications facilities within the City. The ten-year franchise has expired, and the Zayo Group has requested a ten-year renewal substantially along the same lines. With a few minor changes, and the Zayo Group concurrence, Council reached consensus to bring the renewal forward for a first reading.

There is a change in the weather coming that could make fishing difficult, as ice begins to form on our area lakes. This is good news for those who enjoy ice fishing. Ice fishing is already happening at Curlew and Bonaparte lakes, and with the cold weather coming more lakes will offer that opportunity.

There are a lot of options available to anglers here in Central Washington right now. Anglers are catching very nice rainbow trout and a few big kokanee on Lake Roosevelt. On Potholes Reservoir boaters are trolling for walleye, and trout, and even catching some whopper largemouth bass. Shore fishermen are getting some nice rainbow, too. I had

some great fun catching perch on Moses Lake from the shore near the I-90 Bridge a while back, and I am headed there on Friday. In September, I got a photo from my friend Mike McKee, showing an amazing catch of perch that he and his fishing buddy, Joe MacLean had taken on Moses Lake. They had two limits and the fish ranged in size from about 9 to 13 inches! They invited me to come down and, of course, I raced there to meet them. We started near one of the outflows, where they had caught these fish, and found none. We tried spots all over the lake, and I think the grand total was four fish! Mike asked me to try Moses Lake for perch again later in the week, and, or course, I bit.

Then I got a text from my friend Mike McKee, very early in the morning. I was planning to meet him in Moses Lake to go perch fishing. We were going to launch his boat at Blue Heron Park and run down to the I-90 Bridge. Here we would anchor and fill our buckets with perch. However, he caught some kind of bug and couldn't go. Well, I was already rigged up and the truck was loaded with my gear, so I went anyway. On the way down I decided to check on the perch fishing on Winchester Wasteway at the bridge on Road 5. This used to be a great spot to fish for perch in the winter. We used to go there with the whole family, nieces and nephews, the whole gang. When I arrived, I did see some evidence that people had been fishing here. You know, empty worm cartons and leader

packaging. Well, the good news is there are perch here again. The bad news is that they are about 3 inches long. So, I proceeded to Blue Heron Park on Moses Lake.

I saw that there were several anglers on the rip rap bank, but no one on the bridge. I decided to try it from the bridge and had an 11-inch perch in my bucket on my first cast. It took me another fifteen or twenty minutes to get another one though, so I packed it in and headed for home. This may be my last chance to fish here if the weather forecast proves true. Single digit temperatures will put a thin layer of ice on Moses Lake for a while. Many hope that it gets thick enough to allow for safe ice fishing.

I am about to send out my next free E-Letter, for Winter 2024. There are some really exciting developments coming up this winter, and I will be detailing them. One of the most popular species to chase in Eastern Washington is kokanee. Kokanee fishing on Lake Chelan is year-round, and there are limit numbers of kokanee being caught on the big lake right now. Where to find them and how to catch them will be explained in the E-Letter. Lake Roosevelt is famous for giant kokanee, and although the lake level hasn't dropped, whopper kokanee are already being caught just above Grand Coulee Dam. Also, the rainbow fishing has been terrific. There is good news for those who like to fish Rufus Woods Reservoir, like the recent release of some whopper triploids by the Colville Tribe. Subscribers will also get information on the top ice fishing lakes in the region. 

#### **ACTUAL EXPERIENCE MATTERS**



When a real estate broker's bio says they have been in business for many years, consumers may interpret that to mean they have a lot of experience, when that may not be the case at all. Consider the myriad of brokers who do just a few transactions per year to supplement other income and who really don't have much experience, despite touting many years in the business. # PRESS RELEASE: SPOKANE HOME BUILDERS ASSOCIATION DONATES \$77,440 TO WILDFIRE RECOVERY

Medical Lake Mayor Terri Cooper spoke at a press conference this week regarding new long-term wildfire recovery nonprofit, recent relief efforts and to accept major donation

**Spokane, WA., January 8, 2024** — The Spokane Home Builders Association (SHBA), in partnership with Hayden Homes and the National Association of Home Builders (NAHB), held a **press conference to announce and present a \$77,400 gift** to the newly created Spokane Region Long Term Recovery Group (SRLTRG), which is devoted to supporting families on the West Plains and in North Spokane County impacted by last year's devastating wildfires.

The funds were raised as part of a major community fundraising effort led by SHBA in the fall of 2023.

Senior community leaders including Spokane County Commissioner Josh Kerns, Spokane County Commissioner Al French, and Medical Lake Mayor Terri Cooper joined the press conference. Mayor Cooper, who is the chair of the new SRLTRG, discussed ongoing recovery work and shared an update on disaster recovery with the community.

Now a stand-alone nonprofit and with a newly launched website, the SRLTRG brings together both community and faith-based organizations to address critical unmet needs facing those impacted by the wildfire, especially those who lost their homes.

"This major gift from SHBA, and other partners comes at an absolutely critical time for the recovery effort. These resources will go directly toward serving families who lost everything and we could not be more grateful," said Mayor Cooper.

On Aug. 18, 2023, as temperatures climbed and humidity levels plummeted, strong winds stoked a wildfire near Medical Lake. Dubbed the Gray Fire, the fast-moving blaze burned more than 10,000 acres on the West Plains and destroyed 240 homes and nearly 100 other structures. Meanwhile, more than 40 miles to the northeast, another wildfire ignited near Elk, Washington. The Oregon Road Fire burned roughly 11,000 acres in Spokane and Pend Oreille counties and destroyed more than 400 structures, including 126 homes. The Gray and Oregon Road fires were among the most devastating in Washington history, causing a combined loss of \$166 million in assessed property value and leaving hundreds of people homeless.

"A number of our SHBA members came together and said, 'Homes are so important. How can we help these families who lost their homes to rebuild and recover after this disaster?'," said Joel White, Executive Director of SHBA. "The answer was right there – let's pull together and see if we can make a major contribution to the long-term recovery effort. I'm so proud of our members and partners for helping us make this contribution."

This past fall, SHBA created the Spokane Wildfire Disaster Relief Fund to help community members rebuild. Hayden Homes and the NAHB each pledged to contribute \$25,000 matches if SHBA could raise \$25,000 from the public. SHBA members and the general public donated \$12,900. Jason Ramey, owner of Ramey Construction, saw many of his neighbors impacted by the fire and donated more than \$12,000. Green Bluff grower Siemers Farms also contributed \$2,500 collected during the annual Harvest Festival. The public support triggered the matching funds, which NAHB and Hayden Homes are proud to provide.

Together we build a strong community and lead fulfilled lives," said Ben Mc-Gerty, Regional Director for Hayden Homes. "This gift to the long-term recovery effort is our way of saying we understand how important home is. We are all grateful to support our neighbors to rebuild and heal after these devastating fires."

Evernham has an extensive collection of original IROC race cars, including a large collection of the Chevrolet Camaros, which were utilized in the series in the 1970s.


According to a representative with IROC Holdings, the plan at this time is for the IROC event to feature the IROC 1970s Chevrolet Camaro race cars.
